Greetings and Happy New Year. I hope you all have a great Christmas and New Year Holiday. There is nothing better than spending time with friends and family.

Thirty-two members attended the December luncheon excluding guest speaker Thomas Sharp and SIR Area Representative Hugh Thompson. Mr. Sharp is a financial planner and his presentation focused on the long- and short-term effects of "recessions" and what we can do now to decrease out tax burdens. Tom's presentation led to many questions which he aptly addressed; overall, his presentation was well received.

Hugh Thompson gave us a brief overview of State Sir recent activities, stating that the Branches are independent corporations that should do what makes sense to them. He also inducted the new Branch officers and BEC members for 2023.

The annual Hal Higgins Award of Excellence was presented during the meeting. This award recognizes members who make outstanding, above-and-beyond contributions to Branch 14. This year's recipient is Bob Jackson, Branch 14's long-standing Secretary. Bob has been a mainstay in Branch 14's success over the years. Congratulations Bob.

As your new Big Sir, I have two priorities for 2023. The first is to increase our membership to sixty and the second is to add at least one new activity. I hope to get BEC approval of these goals at our next meeting. State Sir's big priority for 2023 is to increase membership across all branches. For us, my goal is to add three more guys to our roster, bringing our total membership to 60. This goal is based on a BEC decision last year to reject a proposed to merger with Branch #133. Such a merger would have put the combined membership at about 125. This number would require a change in venue from Cogir of Stock Ranch to one of the area's Elks Lodges. After discussion, it was the unanimous opinion of BEC members to stay at Stock Ranch, which has a maximum capacity of sixty lunch attendees. We thus rejected the offer to merge. That decision led to my goal for 2023: 3 new members.

The idea of beginning new activities stems from the belief that activities attract new members. Currently, Branch 14 has seven activities: Bowling, Golf, Photography, Poker, Local Touring, Winemaking and Woodworking. One or two branches have forty plus activities. So please put your thinking hats on. What do you enjoy doing besides these seven pursuits? Things that come to mind include Reading, Wine Tasting, Dining, Cooking, Bocce Ball; Pickle Ball; Live Theater; and Bridge (or other card games). Please think about what you like doing and let me know so that we can float a few ideas. My guess is that there are others in our membership that would also enjoy the things that you like; and chances are that you have friends who you currently engage with who might like to join Branch 14 to continue the pursuit.

Well, that is it for my initial remarks. Happy Holidays and I will try to be less verbose in the months ahead.


